OPENING REMARKS: GARY DELACY CLINTON SCHOOLS SUPERINTENDENT

GARY WAS RECENTLY NOMINATED BY HIS PEERS FOR THE IOWA SUPERINTENDENT OF THE YEAR. HE SERVED AS A MATHEMATICS INSTRUCTOR AND BASKETBALL COACH AT CLINTON HIGH SCHOOL FROM 1985 - 2001. AFTER SPENDING 9 YEARS AS A PRINCIPAL AT CAMANCHE, IOWA, AND 7 YEARS AS A SUPERINTENDENT IN DANVILLE IOWA, DELACY RETURNED TO CLINTON IN 2017 AS A SUPERINTENDENT. HE WILL BE RETIRING AT THE END OF THIS JUNE!

ENERGY ASSOCIATES: RADON TESTING BY 2027 JULIE WEISSHARR

JULIE WEISSHAAR, EAIS EXECUTIVE DIRECTOR, FOUNDED EAIS IN 2011. CREATED THE SCHOOL RADON TRAINING & SUPPORT SYSTEM IN 2015. CREATED THE BUILDING OPERATOR PATHWAY IN 2021. HAS WRITTEN AND RECEIVED GRANT FUNDING TO HELP IOWA SCHOOLS FROM THE IOWA CANCER CONSORTIUM, IOWA ENERGY CENTER/IOWA ECONOMIC DEVELOPMENT AUTHORITY, AND IOWA WORKFORCE DEVELOPMENT.

THE GAIL ORCUTT SCHOOL RADON SAFETY LAW (HF 2412) REQUIRES IOWA'S PUBLIC SCHOOLS TO TEST AND FIX ALL OF THEIR ATTENDANCE CENTERS BY 2027, AND EVERY 5 YEARS THEREAFTER. THERE ARE TWO PIECES OF GOOD NEWS WITH THIS: 1) TESTING/FIXING ELEVATED RADON LEVELS WILL PREVENT LUNG CANCER, AND 2) THE LAW PRESERVES SCHOOLS' ABILITY TO TEST FOR RADON THEMSELVES IF THEY HAVE BEEN APPROPRIATELY TRAINED. ATTEND THIS SESSION TO LEARN HOW YOU CAN BECOME APPROPRIATELY TRAINED (AND SUPPORTED) WITH THE SCHOOL RADON TRAINING AND SUPPORT SYSTEM, CREATED AND FACILITATED BY ENERGY ASSOCIATION OF IOWA SCHOOLS AND APPROVED BY THE IOWA DEPARTMENT OF HEALTH AND HUMAN SERVICES.
